COURSE OBJECTIVE: To acquaint students with the techniques of financial management and their applications for business decision making.

A. COURSE CONTENTS (THEORY) (4 CREDITS) (60 marks)

UNIT I

Nature of Financial Management: Concept of Financial management, Scope of Financial Management; Functions of financial Management, Objectives of Financial Management; Principles of Financial Management, Organisation of finance function. Sources of Finance.

Concept and Measurement of Cost of Capital; Measurement of cost of capital; Cost of debt; Cost of perpetual debt; Cost of Equity Share; Cost of Preference Share; Cost of Retained Earning; Computation of weighted average cost of capital based on Historical and Market weights.

UNIT II

Concept of Time Value of Money, present value, future value, and annuity; Long -term investment decisions: Capital Budgeting - Principles and Techniques; Nature and meaning of capital budgeting; Estimation of cash flows; Evaluation techniques - Accounting Rate of Return, Net Present Value, Internal Rate of Return, Profitably Index Method, Pay Back Period Method.

UNIT III

Capital Structures: Approaches to Capital Structure Theories - Net Income approach, Net Operating Income approach, Modigliani-Miller (MM) approach, Traditional approach, Capital Structure and Financial Distress. Optimum Capital Structure. Leverage Analysis: Operating and Financial Leverage; EBIT -EPS analysis; Combined leverage. Dividend Policy Decision - Dividend and Capital; The irrelevance of dividends: General, MM hypothesis; Relevance of dividends: Walter's model, Gordon's model;

UNIT IV

Working Capital Management: Concept, determination of working capital, objectives, estimation of cash concept, factor determining the cash requirement, Preparation of cash budget and cash flow statement. Techniques of inventory control-ABC Analysis & EOQ.
